The New Brunswick Society of Retired Teachers is made up of 2704 members divided into ten Branches. We have had another very challenging but rewarding year; characterized, on the one hand, by frustration, due to limitations imposed by the pandemic, and, on the other hand, by feelings of significant accomplishment and satisfaction, when we have experienced tremendous successes. Our provincial committees have continued fulfilling their mandates to monitor activity in their specialty areas and to advocate for our members. Our Branches have developed more innovative programs to serve, entertain and communicate with our members.

The pandemic has not slowed us down, it has merely caused us to do things differently. As an example, we have produced two very successful webinars (one on travel insurance and one on tax tips) and plan to do more. Our next webinar will be on Estate Planning.

Branches
